This was the first committee that I testified before when I was Chairman and this committee, on both sides of the aisle, was always a great supporter of our work at the Federal Trade Commission. Let me make just a few points. First, we are here primarily because of efforts to cap the rates that merchants pay for the payment card networks. Such caps will inevitably increase card prices to consumers. The merchants efforts to regulate prices, therefore, pose a direct threat to the American consumer. If consumers understood the threat that the merchants campaign poses to the plastic in their wallets, I suspect that we would see nothing less than a revolt. I understand the full fury of the aroused American consumer. While Chairman of the FTC, we created the National Do Not Call Registry. I suspect that many Americans feel as strongly about their plastic as they do about their dinner hour. My second point is...
